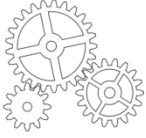

## **Bylaws Tips**



At the TFRW Leadership Bootcamp in Houston last month I spoke about how to keep your club working as a well-oiled machine by making sure your club doesn't conflict with what is written in its bylaws.

By now all clubs should have the TFRW amendments from the state convention added to your bylaws. These amendments are especially important to review during primary and non-partisan elections regarding Republican contested races. If your club did not receive these amendments, please contact me. Your club will receive points for turning in your updated bylaws.

Here are some items that were reviewed at Leadership Bootcamp.

Any bylaw amendment your club makes must be turned in to the Bylaws committee for review before your club can officially accept the amendment.

Make sure your club knows your bylaws regarding executive board voting by email or conference call. If it's not in your bylaws, then your board cannot vote by email or conference call.

Nominating committee member descriptions need to be specified in your bylaws. There should always be an odd number on the committee. A designated number of alternates can also be included. The current sitting President can be an ex-officio member of any committee but the nominating committee. Please review Roberts Rules of Order for nominating committee rules.

In closing, I want to remind you that the grass is not greener on the other side of the fence. Your club **should not** be the thought police or judge on how another club is working. Please work on making your own club's bylaws as good as they can be and show support to your sister clubs. We must be unified for the November election!

## **CARING FOR AMERICA**

By now, I know all of the TFRW Presidents have appointed Caring for America Chairs, and your clubs are starting to get their CFA projects organized. Below are three of the most frequently asked questions, and their answers.

1. What constitutes a Caring for America project?

A. Any **community** volunteer work your club collectively or its members individually perform is considered a CFA event, so long as it **does not involve work for a candidate or elected official**. You should identify yourself as a TFRW member, either by wearing your club name tag, or a TFRW pin, scarf, or any other type of TFRW member identification. These projects may be as varied as your membership chooses, and can encompass volunteering in hospitals, food banks, churches, wounded warriors, and/or rescuing flood victims. The choices are limitless! **VOLUNTEERING IS A GREAT MEMBERSHIP RECRUITMENT TOOL.**

2. When is our report due?

A. Your report is due **June 1, 2017**, and should be turned in to your TFRW State Caring for America Chair. There will be more information about this as that hard deadline approaches. *You should be cheering*, because you have 15 months to get your report done. We recommend you prepare a report on your monthly volunteer work, as it occurs, and take lots and lots of pictures. Remember, there are prizes involved.

3. When and to whom do we report hours?

A. Your hours are cumulative, and will officially be made a part of your final **June 1, 2017** report. We do, however, recommend that you log your members' volunteer hours on a monthly basis, and keep the log in a safe place. You may also send your club hours to the TFRW State Chair for dual safekeeping.

### **Unusual Historical Facts of Famous Americans and U.S. Presidents:**

**Sam Houston:** born March 2, 1793 in Rockbridge County Virginia. When he was in his teens he ran away to live with the Cherokee Indians. He later served as a Congressman and Governor of Tennessee. In 1882 Houston traveled to Texas and became sympathetic to the cause of the Texans struggle to gain their independence from Mexico. After the fall of the Alamo he became a Commander in the Texas army and helped to defeat and capture of the Mexican army and its commander, Mexican president Santa Anna. Sam Houston is the only man in US history to be elected Governor of two different States. He was the 7<sup>th</sup> Governor of both Tennessee and Texas.

**Alexander Graham Bell:** born March 3, 1847 in Edinburgh Scotland. His father was a Professor of Elocution and they were both interested in teaching deaf persons to speak. He chose his own middle name but was called Alec or Aleck by his family. After coming to the United States, he continued with interests working with the deaf and established the Association for the Promotion of Teaching Speech to the Deaf. In March 1876 Bell received the patent for his invention of the telephone and founded the Bell Telephone Company. Among his other inventions was a precursor to the iron lung and a metal detector used to locate the bullet in President Garfield’s body after being shot.

**Albert Einstein:** born March 14, 1897 in Ulm, Germany. His theory of relativity led to new ways of thinking and a Nobel Prize in 1921. He immigrated to the US in 1933 where he became an outspoken critic of Nazi Germany. He warned President Roosevelt about Germany developing the Atomic Bomb, and this encouraged the President to start the secret Manhattan Project.

**Andrew Jackson:** born in a log cabin on March 15, 1767 (Lincoln wasn’t the only one) in Wax, South Carolina. He was the 7<sup>th</sup> President and the first Irish-Catholic President (his parents immigrated from Ireland in 1765). His nickname was ‘Old Hickory’ and he was a target of the first attempted Presidential assassination. He was also the only President to have been a P.O.W.

**James Madison Jr.:** born March 16, 1751 in Port Conway, Virginia. Madison was the 4<sup>th</sup> President. He is best known as the father of the Constitution and the key author of the Bill of Rights. Dolly Madison was one of the most well-loved first ladies.
