

Donald Trump's Positions



TAX REFORM

- Tax relief for middle class Americans
- Simplify the tax code
- Grow the American economy
- Ends the unfair death tax
- Business tax reform to encourage jobs and spur economic growth.
- The Trump Tax Plan is revenue neutral & fully paid for by:
 1. Reducing/eliminating most deductions & loopholes available to the very rich.
 2. A one-time deemed repatriation of corporate cash held overseas at a significantly discounted 10% tax rate.
 3. Reduce/eliminate corporate loopholes that cater to special interests.

COMPELLING MEXICO TO PAY FOR WALL

- Redefine applicable financial institutions to include money transfers like Western Union; redefine “account” to include wire transfers.
 - No alien can wire money outside the US without documented lawful presence in the US.
 - Enforce trade rules through tariffs—Mexico engages in unfair subsidy behavior eliminating thousands of US jobs.
 - Visas will be cancelled (Immigration is a privilege not a right). Illegal immigration has led to lower waged & higher unemployment.
 - Increase in Visa fees—even a small increase would pay for the wall. This includes fees on border crossing cards, which more than 1 million are issued a year.
- Mexico has taken advantage of us with gangs, drug traffickers and cartels have freely exploited our open borders.

IMMIGRATION REFORM

- There must be a wall across the southern border
- Our constitutional system of laws regarding immigration MUST be enforced.
- Any immigration plan must improve jobs, wages & security for all Americans
- Triple the number of ICE Officers; Mexico will pay for the wall.
- Enforce nationwide e-verify to protect jobs for unemployed Americans
- Mandatory return of all criminal aliens
- Detention—not catch & release; Defund sanctuary cities
- Enhance penalties for overstaying a visa
- Cooperate with local gang task forces
- End birthright citizenship

PROTECTING 2ND AMENDMENT RIGHTS

- Enforce the laws on the books
- Fix our broken mental health system
- Defend the rights of law-abiding gun owners
- A national right to carry in all 50 states, like drivers licenses.
- Gun & Magazine bans—The government has no business dictating what types of firearms good, honest people are allowed to own.
- Military Bases & Recruiting Centers—Our military should be allowed to carry firearms on bases and recruiting center. To have a strong military, we need to allow them to defend themselves.

REFORMING US-CHINA TRADE

- Bring China to the bargaining table
- Protect American ingenuity and investment
- Reclaim millions of American jobs and revive American manufacturing
- Withdraw US from the Trans-Pacific Partnership-not ratified
- Tell NAFTA partners we will renegotiate agreement
- Strengthen our negotiating position
- Declare China a currency manipulator
- End China's intellectual property violations
- Eliminate China's illegal export subsidies and other unfair advantages.
- Lower corporate tax rate to 15%; attack our debt & deficit
- Strengthen the US military and deploying it appropriately in the East & South China Seas.

VETERANS ADMINISTRATION

- Ensure veterans get care they need wherever & whenever needed.
- Freedom to choose & force the VA to compete for their dollars
- Support the whole veterans, and “*Make the VA great again.*”
- Increase funding for post-traumatic stress disorder (PTSD), traumatic brain injury & suicide prevention; better support for women as well
- Increase funding for job training & placement services (incentives for companies hiring veterans) education support & business loans.
- End waste, fraud & abuse at the VA & Modernize the VA
- Hire more veterans to care for veterans
- Embed satellite VA clinics in rural & other underserved areas
- Fire corrupt & incompetent VA executive that let our veterans down.
- Empower caregivers to ensure veterans receive quality care quickly.
- *Transform the VA to meet the needs of 21st century service members.*

HEALTHCARE REFORM

- Congress must completely repeal Obamacare
- Modify existing law that prohibits sale of health insurance across state lines
- Allow individuals to fully deduct health insurance premium payments from their tax returns
- Allow the use of Health Savings Accounts (HSAs)—would become part of their estate to pass on to their heirs.
- Require price transparency from all healthcare providers
- Block-grant Medicaid to the states
- Remove barriers to entry into free markets for drug providers offering safe, reliable & cheaper products.
